Current Situation

Reports from the public and officer observations suggest that odour has reduced although we will continue to monitor the situation. We have been continuing odour runs, supported by colleagues from Wyre Borough Council.

We are aware there are other sites in the area that have the potential to cause odour issues - we continue to assess these sites as part of our odour runs.

Regulatory enforcement

We have maintained odour runs, regulatory visits and drone flights over the site since the suspension notice was lifted and will continue to do so.

We understand that the site is not currently accepting waste but is bringing in material to assist with the engineering of the new cell, we have carried out checks to confirm this and will continue to keep a close eye on these operations to ensure regulatory compliance.

Next Steps

We are having further discussions with Transwaste to clearly understand their future intentions for the site and require assurance from them to ensure that the impact of these operations on the community are minimised.

This will include auditing and inspections of the operations and in particular -

- the landfill gas management,
- · leachate management,
- waste acceptance procedures.

We will also place a high level of scrutiny on the engineering, construction and operation in the newest landfill cell.

Investigation at Hillhouse Technology Enterprise Zone

You may already be aware of an investigation which is underway to consider whether contamination has occurred at the Hillhouse Technology Enterprise Zone in Thornton Cleveleys.

The current investigation is focussed on the area around the immediate vicinity of the ACG Chemicals site. This does not extend to the Jameson Road landfill and the ongoing regulation of the Jameson Road (Phase 2) Landfill site is a separate issue.
