Site visit carried out with the Landfill Manager and Natural England representatives. This was to discuss bird control measures and an application for a licence to control wild birds. This licence is considered by Natural England.

During the inspection the tip face was observed. There were significant numbers of gulls present. These were being controlled by a gas cannon and a hawk whilst we were on site. This is in line with the operator's pest management plan. These measures moved the birds away only for them to return 20 minutes later.

Condition 3.6.1 is the relevant condition for pest control:

The activities shall not give rise to the presence of pests which are likely to cause pollution, hazard or annoyance outside the boundary of the site. The operator shall not be taken to have breached this condition if appropriate measures, including, but not limited to, those specified in any approved pests management plan, have been taken to prevent or where that is not practicable, to minimise the presence of pests on the site.

At the time of the inspection further 'appropriate measures' were being considered by the operator. This is not currently recorded as a breach of permit.

You must take immediate action to rectify any non-compliance and prevent repetition. Non-compliance with your permit conditions constitutes an offence* and can result in criminal prosecutions and/or suspension or revocation of a permit. Please read the detailed assessment in Section 2 and the steps you need to take in Section 4 below. *Non-compliance with MSA, MSB & TCM do not constitute an offence but can result in the service of a compliance, suspension and/or revocation notice. Other than the provision of advice and guidance, at present we do not intend to take further enforcement action in respect of the non-compliance identified above. This does not preclude us from taking enforcement action if further relevant information comes to light or advice isn't followed. In respect of the above non-compliance you have been issued with a warning. At present we do not intend to take further enforcement action. This does not preclude us from taking additional enforcement action if further relevant information comes to light or offences continue. We will now consider what enforcement action is appropriate and notify you, referencing this form.

Section 5 - Compliance notes for the Operator

To ensure you correct actual or potential non-compliance we may

- advise on corrective actions verbally or in writing
- require you to take specific actions in writing
- issue a notice
