#### **Current Situation**

During September we have continued to see a reduction in reports regarding odour and gulls at the site. However, we understand that some residents are still being impacted by site operations. Our officers have continued to carry out visits in the local area since our last update and have found that on occasion there are odours within the community. Officers have also noted that gulls are still present on site but numbers appear to be declining.

## **Our Regulation**

Our latest regulatory visit on 20 September showed that Suez are meeting the conditions of the permit. During this visit only occasional landfill gas odour could be detected and there appeared to be a reduction in gull numbers on site.

Suez are continuing to monitor the landfill gas infrastructure and gas extraction to minimize uncontrolled emissions. Over the past few weeks Suez have been continuing to install the permanent cap to the completed parts of the site and last week 7 new gas wells were installed. Further capping is planned to start this week in the current operational areas. These works, along with operations moving away from residential areas, are expected to reduce the impact of odour on the community.

We will continue to carry out compliance visits more regularly, some of those being unannounced.

We continue to hold regular meetings with members of the Suez management and communications teams to understand what they are doing to provide assurance that they are considering all methods to control both odour and reduce the impact from gulls on the community.
