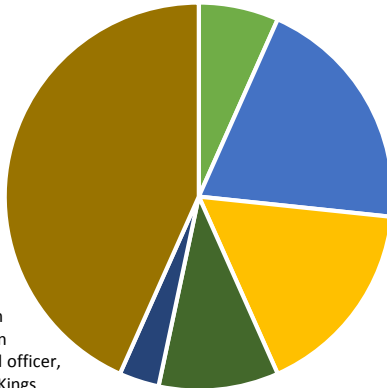


Our community event was designed as a public consultation drop-in event. It enabled us to:

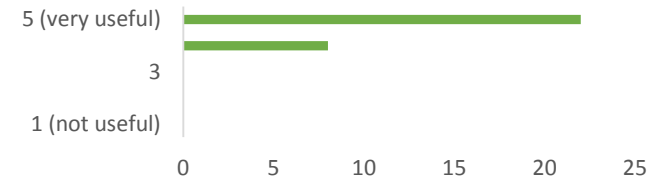

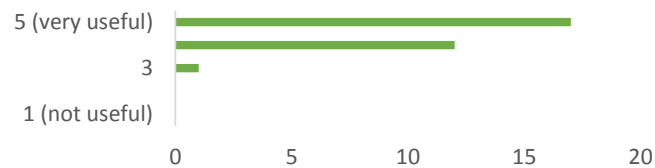
Some of the information received from the public at this event:

- We were flooded in June 2016. The water came around and under our house through the foundations..... If the river bank on the opposite side was lowered it would flood the field and not so much the properties.
- I am strongly against a wall being built to the rear of my garden. There has been no need for much a structure over the past 25+ years
- My main concern is that one of the proposal suggests to turn a field adjacent to our house into a flood storage. I am worried about our flood risk and appearance and accessibility of the field.

Our community event was designed as a public consultation and drop-in event. It enabled us to:

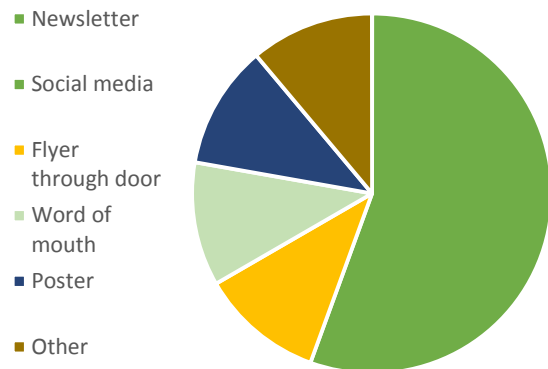
- introduced the public to our proposed flood reduction options

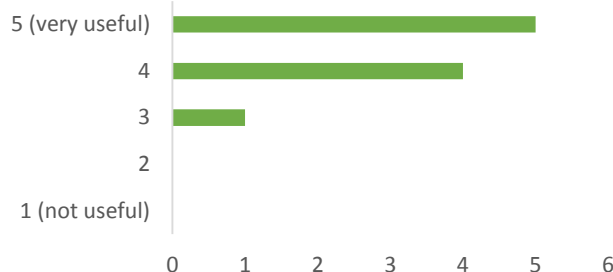

How did you find out about the event?

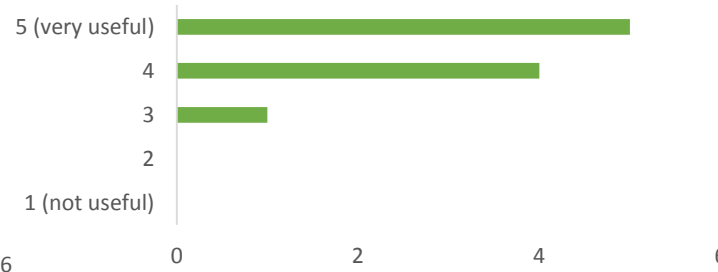

Information received from the public at the Uxbridge drop-in event:

- Outline plan looks OK with potential, however funding will be a major problem unless it is supported by preferably general taxation and council tax.
- More maintenance/ clearing of the River Pinn would aid the flow of the river, enabling the water to get through the areas without the risk of flooding.
