

Roxby Landfill Site – April 2022

Introduction

We are pleased to be bringing you the fourth Environment Agency update on our compliance work at Roxby Landfill operated by Biffa Waste Services Ltd.

Our Commitment

As part of our regulation of the site, we continue to carry out air quality/odour assessments during routine visits to the site which include both announced and unannounced visits.

Our officers are working closely with Biffa Waste Services Ltd to make sure that improvements are made, and odour nuisance is reduced to a minimum.

Latest news

- We have seen a significant reduction in odour reports again this month, with 1 report being received linked to the landfill.
- Biffa has supplied a copy of their revised odour management plan (OMP) for 2022. This was a
 required compliance action from our regulatory work March 2022. We will commence reviewing this
 report and give feedback to Biffa, before the plan is accepted for use on the site.
- We are in the process of undertaking a Landfill Gas Audit on the site, the purpose of this is to ensure that landfill gas is being correctly captured and that infrastructure is installed to the required standard to achieve this. This audit has taken place in two parts, with desk-based reviews of data and a detailed site visit. The onsite audit took place on 27/04/22. No permit breaches were identified during the audit, and the infrastructure on site was assessed to be appropriate, at this point in time. We will produce an audit report in the coming weeks and a Compliance Assessment Report (CAR) for issue to Biffa when the work is completed.

Regulating Biffa

As part of our ongoing expectations, Biffa has this month shared with us their updated plans for the infill of waste and how the site will progress into 2023. These plans show where permanent gas collection wells will be installed and where permanent capping will be completed. The plans proposed are to an acceptable standard to ensure odour is minimised as much as practically possible, and that landfill gas is collected effectively.

Roxby Community Liaison Group

The Environment Agency meets regularly with members of the Roxby Community Liaison Group. The latest meeting was held on 4 February 2022 with representatives from North Lincolnshire Council, Winterton Town Council, Roxby-cum-Risby Parish Council, Biffa, residents, and Andrew Percy MP.
