

## **Roxby Landfill Site – February 2022**

#### Introduction

We are pleased to be bringing you the second Environment Agency update on our compliance work at Roxby Landfill operated by Biffa Waste Services Ltd.

#### **Our Commitment**


As part of our regulation of the site, we continue to carry out air quality/odour assessments during routine visits to the site which include both announced and unannounced visits.

Our officers are working closely with Biffa Waste Services Ltd to make sure that improvements are made, and odour nuisance is reduced to a minimum.

#### Latest news

- All Biffa's proposed engineering works for January have been completed on time.
- We have visited waste producers sending waste to Roxby Landfill with Environment Agency colleagues from the East Midlands area. This work is part of our ongoing investigations into the waste odours and the root cause.
- We have undertaken community odour monitoring, and a site inspection at Roxby Landfill. Two permit breaches were identified. One breach for odour off site at a level likely to cause pollution, and a root cause breach for inappropriate measures being in place at the time.
- We actioned Biffa to take steps to change the gradient of open waste flanks, and install more sacrificial gas collection pipework in the area between cell 12b and cell 13.
- We will undertake another site inspection by the end of February 2022.

### **Regulating Biffa**

We have arranged a meeting in February with the Biffa's senior management team to review their future operational plans. This will ensure they can demonstrate appropriate measures are in place to progress with the ongoing disposal of waste, control and minimise the impact of off-site odour and improve gas collection, together with timescales for final capping of the site.

In the coming months we will also review the sites odour management plan again and undertake a landfill gas audit on the site.

### **Roxby Community Liaison Group**

The Environment Agency meets regularly with members of the Roxby Community Liaison Group. The latest meeting was held on 4 February 2022 with representatives from North Lincolnshire Council, Winterton Town Council, Roxby-cum-Risby Parish Council, Biffa, residents, and Andrew Percy MP.
