Foreword

The Regional Flood and Coastal Committees (RFCCs) are Committees established by the Environment Agency under the Flood and Water Management Act 2010 that brings together members appointed by Lead Local Flood Authorities (LLFAs) and independent members with relevant experience for three purposes:

- To ensure there are coherent plans for identifying, communicating and managing flood and coastal erosion risks across catchments and shorelines.
- To promote efficient, targeted and risk-based investment in flood and coastal erosion risk management that optimises value for money and benefits for local communities.
- To provide a link between the Environment Agency, LLFAs and other risk management authorities, and other relevant bodies to bring about mutual understanding of flood and coastal erosion risks in its area.

There are 12 Committees in England and each has a Chair appointed by Defra. The Anglian (Central) RFCC covers the River Great Ouse catchment and the North West Norfolk coast in East Anglia.

The aim of the consultation was to gain feedback from all those individuals, groups and organisations, who are affected by, or interested in, the proposed Variation of the Composition and Name of the Anglian (Central) Regional Flood and Coastal Committee, in line with The Regional Flood and Coastal Committee (England and Wales) Regulations 2011.

1. Introduction

The proposed local government reorganisations in Northamptonshire and Buckinghamshire, planned from April 2020, will create new unitary authorities. As a result, the existing Composition of the Anglian (Central) Regional Flood and Coastal Committee will need to be varied to accommodate these changes, as the existing Lead Local Flood Authorities (LLFAs) for these areas will no longer exist. In addition to this variation, the Anglian (Central) Regional Flood and Coastal Committee has taken this opportunity to examine the overall allocation of Lead Local Flood Authority Membership. We have therefore consulted on the proposals for the Variation to the Composition of the Anglian (Central) Regional Flood and Coastal Committee. The variation process is set out in The Regional Flood and Coastal Committee (England and Wales) Regulations 2011, Part 3 (9) and requires Ministerial approval.

The Composition Variation must be made in line with the Regional Flood and Coastal Committee (England and Wales) Regulations 2011 and subsequently there are certain limitations when proposing a new scheme.

In 2011 when the transition was made from Regional Flood Defence Committees to Regional Flood and Coastal Committees, it was confirmed that Lead Local Flood Authority (LLFA) representation was a matter for individual RFCCs to propose.

It is proposed to change the name of the RFCC from Anglian (Central) Regional Flood and Coastal Committee to Anglian (Great Ouse) Regional Flood and Coastal Committee.

2. How we ran the Consultation

We invited comments from those individuals, groups and organisations, who are affected by, or interested in, the proposed Variation of the Composition and Name of the Anglian (Central) Regional Flood and Coastal Committee (RFCC), in line with The Regional Flood and Coastal Committee (England and Wales) Regulations 2011.

We ran an e-consultation and made hard copies available to those who requested them. We also engaged with key stakeholders to explain our proposals and to understand their views. This document summarises the responses to the consultation questions and any relevant points raised.

We thanked all respondents for their time and contribution to this consultation.

2.1. Proposals

The consultation focussed on two main areas:

- Two options for the Variation to the Composition of the Anglian (Central) Regional Flood and Coastal Committee.
- Proposed name change from Anglian (Central) Regional Flood and Coastal Committee to Anglian (Great Ouse) Regional Flood and Coastal Committee.

2.2. Consultation Period

We ran the consultation from the 7th May 2019 to 18th June 2019.

2.3. Level of Response

We received a total of 15 responses, of which:

- 8 were from organisations or groups.
- 7 were from individuals.

3. Summary of Responses to each Consultation Question

3.1. Question 1: Which Option is your preference for the Composition of the Anglian (Central) Regional Flood and Coastal Committee?

Number of responses recorded against each of the three possible answers:

Option 1 - Do Minimum: 4 out of the 15 responses.

Option 2 - Better reflecting spread of Tax Base across Lead Local Flood Authorities: 8 out of the 15 responses.

Neither: 2 out of the 15 responses.

Summary of relevant key points raised:

- Those LLFAs that Buckinghamshire County Council would share with in Option 1 have a common rural nature. Option 2 does not account for future growth, meaning is the timing right to make such changes.
- Option 2 - Better reflects spread of tax base which is something Councils regularly discuss.
- Alternative proposal from Hertfordshire County Council was to remove shared seats and for each LLFA to have a minimum of one seat, with the Tax Base used to reflect where more than one seat is appropriate.

The responses to this question were carefully considered and reviewed by the Anglian (Central) Regional Flood and Coastal Committee at their Meeting on the 18th July 2019, please see **Section 4** for details of the outcome.

3.2. Question 2: Should the Anglian (Central) Regional Flood and Coastal Committee change the shared seats to a Partnership approach?

Number of responses recorded against each of the four possible answers:

Yes: 9 out of the 15 responses.

No: 4 out of the 15 responses.

Don't know: 0 out of the 15 responses.

Other: 1 out of the 15 responses.

Summary of relevant key points raised:

- Rotating seat is fair and equitable within current model. Concern about Milton Keynes Council ability to represent rural communities.
- This would hopefully lead elected members being more committed to the works of the group.
- This could work but would have LLFA resourcing impacts.

3.3. Question 3: Please let us know if you think there is anything else we should be considering?

Summary of relevant key points raised:

- None.

3.4. Question 4: Do you agree with the new title for the Regional Flood and Coastal Committee?

Number of responses recorded against each of the four possible answers:

Yes: 13 out of the 15 responses.

No: 1 out of the 15 responses.

Don't know: 0 out of the 15 responses.

Other: 1 out of the 15 responses.

Summary of relevant key points raised:

- Reflects the geography of the Committees responsibility, easier to explain the role to others.
- Makes perfect sense to name the Committee after the catchment as our coverage is then very clear.
- The new title is welcomed.
- The name is confusing and not representative of the geographical area.

4.1. Composition of the RFCC

The Committee decided that Option 2 (Better reflecting spread of Tax Base across Lead Local Flood Authorities) was the Variation to the Composition of the Anglian (Central) Regional Flood and Coastal Committee that was to be submitted in two parts (Phase 1 and Phase 2) for Ministerial approval. The initial Variation was split into two Phases because the local government reorganisation in Northamptonshire was postponed from April 2020 to April 2021:

- Phase 1, to be enacted from the 1st April 2020, covers the change to the Composition as per Option 2 and the local government reorganisation in Buckinghamshire.
- Phase 2, to be enacted from the 1st April 2021, covers the local government reorganisation in Northamptonshire.

The Environment Agency FCRM Committee considered and approved Phase 1 on behalf of the Environment Agency Board.

The Minister of State considered and approved the Phase 1 Variation that will be enacted from the 1st April 2020.

Phase 2 implementation will involve in 2020, approval from the Environment Agency FCRM Committee before submission to the Minister of State for consideration and approval before 1st December 2020 and subsequent enactment from the 1st April 2021.

4.2. Name of the RFCC

The Anglian (Central) Regional Flood and Coastal Committee recommended a change of name of the RFCC to Anglian (Great Ouse) Regional Flood and Coastal Committee. The Environment Agency agreed to apply Regulation 5 of The Regional Flood and Coastal Committees (England and Wales) Regulations 2011 and the name was changed from October 2019.
