

Yarm Flood Alleviation Scheme

November 2024 Newsletter

Welcome to the November 2024 edition of the Yarm Flood Alleviation Scheme newsletter. This newsletter forms one of the ways that we will keep you updated on our Flood Alleviation works in Yarm, as the project develops.

Continuation of Works – Flood Gates

Construction on the Yarm Flood Alleviation Scheme continues with **all Public gates having now been installed**, including **Gates 27 to 32** and the publicly accessible **Gates 2, 17 and 23**. A small amount of reinstatement is required on these which will be completed in the coming weeks.

Works have now progressed to the **second phase** of the project, on the West and North sides of Yarm. **Gates 19 – 24** have now been installed, with a section of footpath between the rail bridge and the road bridge to be reinstated. **Gates 1, 3 and 4** have also been installed with associated works and re-instatement being completed.

Works on the **West Side of Yarm** to install new flood gates along True Lovers Walk are continuing. In addition, access improvements are being carried out on a number of Gates adjacent to True Lovers Walk – this work involves the construction of new access steps and platforms which are designed to provide a safe working area when operating the gates. Unfortunately access along some sections of True Lovers Walk will continue to be restricted for the rest of 2024 to accommodate the remainder of the works. This closure is necessary to facilitate access needs to safely deliver the scheme, however we are doing everything possible to re-open this section of footpath as soon as we can. Upon completion of the work, the area will be fully re-instated.

We apologise for any inconvenience our activities may cause and thank you for your continued patience and cooperation.

The third and final phase of the works are predominantly within private property, although some access will be required along True Lovers Walk due to the required plant sizes and material movements. The works will finish in the New Year.

We have spoken directly with all landowners and occupants who will be impacted by the replacement of this next phase of gates and we will continue to engage with landowners and stakeholders about the ongoing work.

Please note that all dates provided are our best estimate at this moment in time, and may change, especially if we experience poor weather and the flood gates need to be operated.
