During this inspection officers checked to see if oil had been recovered from natural gas condensate. On this occasion no oil had been collected in the dedicated tank. Fluid level indicators on the tank confirmed no presence of oil.

The tank was in good condition and located within a temporary bunded area within the lined well pad.

No non-compliances were identified.
