Inspection Topic - continued from inspection on 4th October 2018 (report reference UP3431VF/0316303).

- Micro seismic Monitoring for fracture growth
- General permit requirements including frac fluid flow monitoring.

Micro seismic Monitoring

Twenty-four geophones are now in place and this work was completed on Sunday. Diagnostic testing was carried out during the installation. The micro seismic monitoring (wiggle trace) was inspected in the wire line cabin and all down hole geophones were communicating. A diagram of the installed geophones will be viewed during a later inspection.

The capture, interpretation and storage of micro seismic data was discussed. A draft decision making protocol has been produced by Cuadrilla to follow in the case of an event at the subsurface permit boundary within the shale formation. Cuadrilla are training their Fracturing Contractors on the requirements of this protocol which is important for permit compliance. Confirmation was provided that if systems go down, for example the internet connection is lost compromising data analysis, there would be no pumping of fracturing fluid until connection had been restored.

Confirmation was provided that the raw data from the geophones is stored on a hard drive and this would be available for us to review if required.

A discussion was had around the interpretation of micro seismic events during fracturing stages and the elimination of false events/background noise (isolated events or clusters of events not related to the hydraulic fracturing such as natural seismic ground movement, quarry blasts). The Environment Agency should be notified of false events during the daily report.

Fracturing Fluid Flow

Fracturing fluid flow rate is recorded by the Fracturing Contractor. This is recorded every second and stored. **Cuadrilla must ensure that they are provided with this data to meet permit requirements on retention of data.**

There is a flowmeter in place to record water flow into a buffer tank and a flowmeter to record the fracturing fluid (including proppant). The permit limits refer to the fracturing fluid flow rate limited to 106.25l/s. The flowmeter installed to measure the fracturing fluid flow rate is not currently MCERTS certified or MCERTS accredited.

Permit condition 3.5.4 states that:

Monitoring equipment, techniques, personnel and organisations employed for the emissions monitoring programme and the environmental or other monitoring specified in condition 3.5.1 shall have either MCERTS certification or MCERTS accreditation (as appropriate), where available, unless otherwise agreed in writing by the Environment Agency.

Cuadrilla have opted to request a written agreement with the Environment Agency to approve the use of the chosen flow meter based on a substantially lower flow rate than permitted **which will be required prior to the injection of hydraulic fracturing fluid.**
