This was a joint inspection with the Oil & Gas Authority.

Hydraulic fracturing was not taking place at the time of the inspection. Cementing equipment had arrived on site and was being set up to enable the cementing works to be completed to seal stages 30 and 31.


The flowback area was inspected and discussed with Cuadrilla's contractor and the use of the open topped tanks discussed (refer to CAR form UP3431VF/0317139).

A check was conducted with the operator on follow-up actions from the first EMMP audit covering ambient air monitoring conducted on 24 October. Full details will be provided in the audit report.

No signs of leaks or well pad integrity issues were noted during the site walkover.

Daily morning reports

The daily morning reports have been received despite no hydraulic fracturing activities. The reports confirm that there have not been any seismic activity or sub-surface permit boundary breaches
