We carried out a visual inspection of the 4 wells drilled over the last two weeks. Cuadrilla (you) were on site during our visit. In addition the drilling equipment was being moved today by the drillers to enable it to re-deployed at your Roseacre Wood site.

Following our inspection we have identified two versions of your Groundwater Monitoring Plan both dated March 2016 and both Issue 3 with slightly amended text. Please ensure this does not happen again and amended versions are given new issue numbers. The text has changed in the version you submitted to us on the 1<sup>st</sup> June 2016 regarding drilling notification. In this latter version you have included the additional fourth borehole we requested but we observed that you did not drill the CMT in the NW corner as stated and instead the CMT was seen to the north of the borehole location plan. Full details of all 4 as drilled/built boreholes are to be submitted to satisfy P07 and we will require written confirmation that 4 wells not 3 wells are to be monitored in line with P08.

We also looked at the excavated drilling mud/clay on site within the skip. The code that should be used for disposal of this waste is EWC 01 05 04 Freshwater drilling muds and waste (non-hazardous).
