On 14 June 2018 we issued a standard rules permit allowing the storage of crude oil at the same location as shale gas exploratory activities permitted under KB3395DE (RSR) and AB3101MW (Installations). Crude oil in the standard rules permit includes gas condensate, which can arise when liquid hydrocarbons held in gaseous form at high reservoir temperatures are produced to the surface. As the liquid hydrocarbons cool they condense out of the gas. The standard rules permit allows Cuadrilla (subject to the conditions of that permit) to store and handle this gas condensate should it occur.

During this inspection officers checked to see if oil had been recovered from natural gas condensate. On this occasion no oil had been collected in the dedicated tank. No non-compliances were identified.
