The Mining Waste Facility Annual Report as required by permit condition 4.2.3 was submitted to the Environment Agency in February 2018.

Condition 4.2.3 requires the operator, for activities A3 and A4, namely the above ground hazardous waste and non-hazardous waste facility, to submit a report on the behaviour of the mining waste facility over the previous year. In order to demonstrate compliance with this condition the report should include the results of the monitoring and assessment carried out in accordance with the conditions of the permit including the interpretive review of that data.


Version 2 of the Mining Waste Facility Annual Report was submitted to the Environment Agency on 28 August 2018 following comments from CAR Form UP3431VF/0311247 dated 31 July 2018.

The report is acceptable and meets the requirements of condition 4.2.3 of the permit. This inspection report now completes our assessment of condition 4.2.3.
