In accordance with permit condition, 2.4.4 a report referenced 'Well Integrity Report - PNR Well 1/1z' has been submitted covering the integrity testing of the well 1/1z. The report confirms that the requirements in permit condition 2.3.4 and section 2.2.4 of the Waste Management Plan Version 8 have been met.

A site inspection on the 19th April was conducted jointly with the Health & Safety Executive (HSE) Wells Inspector in the presence also of an Independant Well Examiner to assess the requirements of well integrity testing. Our remit is to assess well integrity for groundwater protection purposes, while the HSE make their assessment on the basis of well safety. A record of this inspection has previously been provided.

The document has been submitted in compliance with the permit conditions stated above, the following comments provide a summary of the information reviewed.

The report explains how the permit condition has been complied with. In the document there is an error in the permit condition number where condition 2.2.3 should be condition 2.3.4. This does not change the validity of the information provided. Pre-operational condition PO5 has a permit condition number error also where condition 2.3.3 should be 2.3.4.

Permit condition 2.3.4 requires steps specified in the permit condition to be followed in the construction of the well. This condition references the notice given under Section 199 of the Water Resources Act 1991 prior to drilling the well. One deviation was identified in the well integrity report from the planned casing and cementing work discussed in the Section 199 notice, however this deviation achieved the same purpose of ensuring an adequate cement bond of the 6" hole.

Deviations in the intended method used to set the casing in a well can occur as a result of design changes, we are satisfied that the method used is appropriate.

Confirmation has been provided in the well integrity report that outlets from the injection boreholes will remain within the shale formation (target strata) at all times.

Confirmation has been provided that no part of the injection borehole is situated within 10 metres of a watercourse, or any other surface water; or within 200 metres of a designated site, or within 200 metres of a sensitive receptor.

The injection borehole is not located within a SPZ1 or 50 metres of a well or borehole used for drinking water.

Section 2.2.4 of the Waste Management Plan Version 8 (WMP) explains the process of well integrity testing and the steps to follow that include pressure testing, formation integrity testing and/or cement bond logging using a wireline log, this confirms cementation integrity and demonstrates that the well has been constructed appropriately and integrity can be maintained during exploration activities.

The report under scrutiney in this review has followed section 2.2.4 of the WMP.

The report also provides as built drawings as required by pre-operational condition PO6. The report however does not include the grid reference for the injection borehole (well) location, it is recommended that the report is amended to include this.
