This site inspection was undertaken following the receipt of a report to the Environment Agency's Incident Communication Service regarding surface water flooding at the site.

Officers spoke to representatives from Cuadrilla and discussed water management on site.

During a weekend of heavy persistent rain the operator managed water on site by utilising available storage tanks and bunds.

The internal sealed drainage ditch had reached capacity at the weekend, however, levels were lower during the site inspection and no damage or impact on the stability of the drainage ditch was noted.

In liaison with the Local Authority the operator was given permission to tanker off water to maintain capacity on site and enable them to continue to safely store rainwater.

No water was found to have left site. Surrounding field drains were inundated with water which caused water to pond outside of the site and caused water to enter the site. Photographs taken during the weekend by on site cameras confirmed this.

Observations on site and from the perimeter of the site confirmed that there was no evidence of pollution leaving the site (e.g. Oily sheens/silt).

Considering the amount of rainfall over the weekend the company were found to have managed water well. No permit breaches were identified.

A follow-up visit to the site will be undertaken to ensure surface water continues to be managed in compliance with the permit and if required, management systems are adapted to better manage surface waters.
