Cuadrilla have submitted a risk assessment and supporting evidence for a change to their procedure for sampling and discharging clean uncontaminated surface water (rainwater) during the well suspension period at Preston New Road. The revised procedure reflects the reduction in operations and environmental risk at the site. The site is not currently operational.

Environment Agency Technical Specialists have assessed the proposal and we approve the changes to the procedures and monitoring specified in conditions 2.3.1 (Activity Reference A6, Surface Water Management Plan) and 3.5.1a (point source emissions specified in table S3.2) of the permit. The operator has demonstrated that since the well suspension period started the discharged surface water from the site is of a similar quality to that in Carr Bridge Brook. All wastes have been removed from site and there is a very low risk of any contamination of the surface water collected on the site. We therefore agree that during this well suspension it is not necessary to analyse the collected surface water (rainwater) before discharge to Carr Bridge Brook.

The discharge rate shall be kept below 12 litres/second. The operator will not discharge surface water during a flood alert or if levels of Carr Bridge Brook are above the trigger level (3.5mAOD). During these periods the operator will tanker surface water off site if required.

An interceptor and silt trap is in place to prevent silt pollution. The operator will ensure that all infrastructure is regularly inspected and maintained.

We expect the full surface water monitoring requirements to resume 4 weeks prior to any changes to the operational profile of the site.
