The approved pre-operational procedure for treated surface water discharge authorised in accordance with condition PO11 of the operator's permit requires a commissioning exercise to be undertaken prior to discharge taking place. This commissioning process (as set out in section 4 of the approved procedure) involves discharging different flowrates to observe the resulting change in water level of Carr Bridge Brook. The purpose of this is to check the predicted relationship between flow and water level in line with the procedure and confirm or revise as necessary.

The procedure states that commissioning will be done in dry weather conditions (i.e. no rainfall for previous two days) so that there is steady flow in Carr Bridge Brook. Due to the recent wet weather the operator has not been able to do the commissioning work and has proposed that steady flow conditions can also be gained after periods of low rainfall. They therefore propose to measure the water level in Carr Bridge Brook every 15-minues for 1hour to ensure that there is steady flow and then undertake an initial commissioning exercise. Following this initial commissioning work the operator plans to temporarily discharge treated surface water. This will be a one-off discharge to allow the operator to free-up storage capacity for any future rainfall. A future commissioning exercise after dry weather conditions will then be done before any further discharge takes place.

Following discussion with the operator about risks of the commissioning work under low rainfall conditions we are satisfied that the initial commissioning procedure is both comprehensive and protective and will provide the necessary information on the relationship between flow and water level to allow a temporary discharge of treated surface water.

In addition to the measurements outlined above, sampling of the treated surface water will be undertaken for the substances/parameters required in Table S3.2 of the permit prior to discharge.
