Assurance visit to site for review of flowmeter progress and frac fluid sampling procedures.

At the same time as the inspection, an EA officer from the ambient air monitoring team carried out calibration on the Environment Agency mobile monitoring facility on site.

Water

Third Energy have been carrying out a cleaning activity on the water for use in hydraulic fracturing. This was nearly complete at the time of inspection.

Sampling of frac fluid

The permit (Table S3.2) requires the analysis of fracture fluid per fracture injection from an instantaneous spot sample. The sampling point and logistics of taking this and ensuring it is a representative sample were discussed with Third Energy and Envireauwater and updates will be made to the frac fluid sampling procedure in the KM8 EMS. Logistics of EA sampling during frac operations and personnel on site during HF operations were also discussed.

Flowmeter

Further plans for verification tests on the flowmeter were reviewed. Third Energy agreed to send through the verification process that will be used. 2 x 6" flowmeters had been sent for calibration. Envireauwater are putting together the verification process for the flowmeters in situ and will be running these tests. Please keep us informed of when this will be carried out.

Frac sand

A final sample was taken of frac sand (20/40) for reference.

Air Monitoring

An air monitoring report has been received for time period 6th - 19th November. This will be placed on the public register.

Noise Report

The noise report from the Pre-Stimulation Workover, period 14th October to 1st November 2017 has been received and will be placed on the public register.

Surface Water and Groundwater Reporting

Report received for the 15/11/17. This will be placed on the public register.
