### Water Monitoring

Current monitoring frequencies and suites are those agreed in CAR form: 402444/0303341, issued 6th of March 18, and outlined in the Third Energy document entitled:

*Proposal for Variation of Monitoring at the KMA Well Site TEGL-KM8HF-029 Rev. 1*

The Environment Agency has received a document from Third Energy referenced: *Variation to Monitoring Requirements at the KMA Wellsite, 17th July 2018* requesting to reduce the current water monitoring at KMA.

Section 3 of the document states that:

*"The chemical products that have been stored at the KMA wellsite since the temporary suspension in operations in February 2018 were all removed on 29/06/2018 for safe storage at Knapton Generating Station. Since the timings for the recommencement of operations are unknown, it has been decided to curtail the current monitoring scheme."*

and continues:

*"It is therefore proposed to curtail water monitoring at the KMA wellsite to monthly monitoring for dissolved methane. The monitoring will be carried out on water samples collected from the groundwater monitoring boreholes at the KMA wellsite (monitoring locations BHA – BHE) and will take effect from July 2018."*

We note that Third Energy understand that they will need to resume the full suite of monthly water quality monitoring 3 months before operations resume:

*"It is acknowledged that the full suite of water quality monitoring required by the permit will need to resume 3 months prior to operations at the wellsite."*

Third Energy are not carrying out any work on the KM8 activity on site, the chemical products associated with KM8 activities have been removed, and they are currently in a suspended period of operation.

**This CAR forms an agreement in writing for a temporary change to the Emissions Monitoring Plan as described in the proposal document Variation to Monitoring Requirements at the KMA Wellsite, 17th July 2018 during this period of suspension.**

**Please note that you should ensure that other regulators who have an interest in monitoring have also agreed this plan.**
