# B66 2PG, European Metal Recycling Limited: environmental permit consultation

#### The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for European Metal Recycling Limited. Please use the reference number below when making comments on this application.

- Regulated facility type: Currently their site at Downing Street, Smethwick operates under three different

authorisations: a standard rules permit for the area to the south of Downing Street, a bespoke

environmental permit, which was formerly a waste management licence for an area to the north of Downing

Street (Alfred Street site) and a T9 Exemption.

1.1.3 The aim of this variation application is to amalgamate these three authorisations into

one bespoke permit for metal recycling ahead of changes to the exemptions that are due next year.
