B70 0EB, 2 Sisters Food Group Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for 2 Sisters Food Group Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/JP3433WU/V003
- Regulated facility type: Application for a substantial variation to an existing poultry processing site to include a new automated processing line which will increase production capacity on site from 654.5 tonnes/week to 1,830 tonnes/week (approximately increase from 93.5 tonnes/day to 261 tonnes/day). The variation also includes updates to the refrigeration system, replacement of existing boilers systems, and updates to Category 2 and 3 waste handling procedures.
- Regulated facility location: Dial Lane Meat Packing Facility, Dial Lane, West Bromwich, B70 0EB
