Payment of £749.00 has been made.

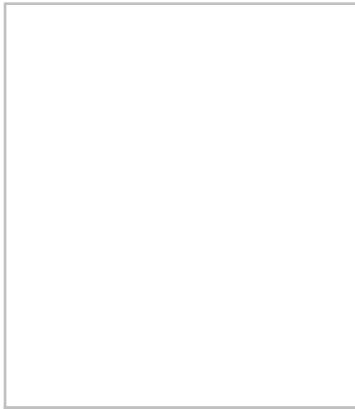

We need more information about your application and underpayment of application charge

I write further to my email dated 15/09/22 and our conversation today. I have discussed your application with colleagues. To help us decide if the noise at the site will mean that we need to ask for a Noise Impact Assessment (NIA) and Noise Management Plan (NMP) we need some further information.

- Provide a copy of the manufacturer's specification for the pump that will be used to pump water into the membrane bag and to pump water into the holding tank.
- Confirm at what times road sweepers will be bringing waste to the site and tipping it into the skip and removing it from the site.
- Confirm at what times you may move additional skips onto the sealed drainage area.

Please can you provide this information within 10 working days, or sooner if at all possible.

If you wish to discuss this, or anything that was requested in my not duly made email on 15/09/22, please do not hesitate to contact me.
