Dear Sue

Further to your email below, we are pleased to provide further clarification of the waste operations as follows.

Crushing and screening of waste road planings will be restricted to 7am to 5pm Monday to Friday and 7am-12noon on Saturdays. No crushing or screening of waste will be undertaken prior to 7am.

Crushing of waste is undertaken on a campaign basis (i.e. not on a routine/daily basis). Once sufficient material is available on site (approximately 15,000 to 20,000 tonnes), mobile crushing plant is brought to the site and material is crushed. It is anticipated that crushing will be undertaken 2 or 3 times a year for 4 to 6 weeks at a time.

We trust that this information, together with the information provided on 27 November 2025, 3 December 2025 and in the application to vary the permit will be sufficient to confirm that a quantitative Noise Impact Assessment will not be required. As discussed previously, we would be pleased to provide a Noise Management Plan which explains the mitigation measures employed at the site if it would be of assistance and provide further assurance to the Environment Agency that noise emissions at the site are suitably controlled as demonstrated by the absence of any noise complaints in relation to the waste activities since the permit was issued.
