Requirements relating to historic and archaeological features in the Sustainable Farming Incentive

[Scheduled Monument Consent](#) is required from Historic England (on behalf of the Department of Culture, Media and Sport (DCMS)) for all above and below ground works on a scheduled monument, including all actions involving ground disturbance. It is an offence to undertake works on a scheduled monument without prior written permission being obtained from Historic England.

You must follow the requirements below when completing your selected SFI actions on any area within a land parcel that contains historic and archaeological features listed in this SFI HEFER.

Boundaries	CHRW3	Get consent from Historic England before establishing any new hedgerow trees within a Scheduled Monument.
Buffer strips	CAHL4	Use this action to protect upstanding historic and archaeological features, such as earthworks, in-field historic structures and buildings.
	CIGL3	Use this action to protect upstanding historic and archaeological features, such as earthworks, in-field historic structures and buildings.
	BFS2	Do not undertake this action on any area within a land parcel that contains historic and archaeological features as identified on your SFI HEFER.
	BFS3	Do not undertake this action on any area within a land parcel that contains historic and archaeological features as identified on your SFI HEFER.
	BFS6	Do not undertake this action on any area within a land parcel that contains historic and archaeological features as identified on your SFI HEFER.

Heritage	HEF1	Use this action to maintain traditional farm and forestry buildings on your holding.
	HEF2	*Available late 2024*. Use this action to take scheduled monuments out of cultivation.
	HEF3	*Available late 2024*. Use this action to undertake reduced depth, non-inversion cultivation on scheduled monuments.
	HEF4	Use this action to control scrub on historic and archaeological features.
	HEF5	Use this action to manage historic and archaeological features under grassland.
	HEF6	Use this action to maintain designed and engineered water bodies.
	HEF8	Use this action to maintain traditional farm and forestry buildings in remote areas in your holding.
	HEF9	*Available late 2024*. Use this action to undertake restricted depth establishment under an arable rotation on scheduled monuments.
Integrated pest management	CIPM3	You must avoid growing deep rooted species on any area within a land parcel that contains historic or archaeological features identified in your SFI HEFER.
Moorland	CMOR1	Assess and record the presence of historical and archaeological features; identify and record opportunities for protecting and enhancing historic and archaeological features as one of the environmental benefits provided by your moorland.
	UPL1-3	Use the appropriate grazing level to ensure that historic or archaeological features are neither over or under grazed.
	UPL7-10	Removal of stock over winter is recommended for land with historic or archaeological features.
Nutrient management	CNUM1	Where possible, avoid taking soil samples from historic or archaeological features identified on your HEFER. If you need to take soil samples on any area of land containing a scheduled monument get consent from Historic England before you take the soil samples. 	SOH1	This action is suitable for some historic and archaeological features, where these have been identified as below ground or buried remains on your SFI HEFER. You must not carry out subsoiling on land with historic or archaeological features, including scheduled monuments (which would require scheduled monument consent).
	SOH2	You must avoid growing deep rooted species of companion crop on any area within a land parcel that contains historic or archaeological features identified in your SFI HEFER.
	SOH3	You must avoid growing deep rooted species of companion crop on any area within a land parcel that contains historic or archaeological features identified in your SFI HEFER.

Capital items, such as fencing, planting new hedgerows and trees may damage historic and archaeological features. Ensure you follow appropriate guidance and seek relevant consents when applying for capital items to accompany your Sustainable Farming Incentive actions.
