# BS10 7RS, Cliffeville Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Cliffeville Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/LP3199FS/V004
- Regulated facility type: The activity will fall under Schedule 1 of the EP Regulations: Section 5.4 A1(a)(ii)
  Disposal of non-hazardous waste in a facility with a capacity exceeding 50 tonnes per day by physico chemical treatment.
  - Application to add a physico chemical leachate treatment activity via a Methane Stripping Plant (MSP) to treat leachate arising from the landfill prior to discharge to sewer. Leachate is generated from the closed landfill. The MSP to be located within the existing Environmental Permit boundary near the site entrance.
- Regulated facility location: Berwick Farm Landfill Site, Berwick Lane, Bristol, BS10 7RS
