### BS11 9FG, Grundon Waste Management Limited: environmental permit consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Grundon Waste Management Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/LP3241QA/V009

Regulated facility type: The variation to the existing permit is to include:

- 5.3A(1) (a) (ii) use of physico-chemical treatment to recover hazardous waste with a capacity exceeding 10 tonnes per day
- 5.3A(1) (a) (iii) use of blending and mixing to recover or dispose of hazardous waste exceeding 10 tonnes per day
- 5.3A (1) (a) (iv) repackaging prior to submission to any of the other activities listed in section 5.3 or 5.1 exceeding 10 tonnes per day
- Waste Operation treatment of non hazardous waste by depackaging, blending, bulking and shredding
- 5.6A(1)(a) temporary storage of hazardous waste
- Regulated facility location: Avonmouth MBT Facility, Kings Weston Lane, Bristol, BS11 9FG
