CH2 4NR, Encyclis Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

- Regulated facility type: Permitted activity The incineration of non-hazardous waste in a waste incineration plant or waste co-incineration plant with a capacity exceeding 3 tonnes per hour.
- New activity Capture of carbon dioxide streams from an installation for the purposes of geological storage pursuant to Chapter 3 of Part 1 of the Energy Act 2008 and other EU-derived domestic legislation which transposed Directive 2009/31/EC on the geological storage of carbon dioxide in relation to England and Wales.
- Regulated facility location: Protos Energy Recovery Facility, Grinsome Road, Elton, Chesire, CH2 4NR
