Please see attached from F1 with the confidentiality permissions unticked

- Part A – Q1 We applied as a 'registered company or a corporate body' - so sections 2/3/4 do not apply as they are for 'individuals', 'organization of individuals', and 'public bodies' respectively. We have completed Part A, Q1, Section 5 fully - as only that is applicable.
- Part B2 – Section 2

Section 2 in Part B2 is spread over pages 1, 2 3 and 4.

We have completed 2a and 2b (pages 1 and 2) as these sections are relevant.

2c is NOT relevant to us as that is for more than one regulated facility on the site (so instructions in 2b ask us to move to 2d).

2d, 2e, and 2f have been completed (but the answers are all NO as it is not applicable).

2g is for multi-operator installation - again not applicable to our application and hence not completed.

If you're not able to view the ticks (e.g. against the 'No' for Q 2d, 2e, and 2f OR cannot see 2a and 2b completed, he may need to change his 'view' settings

In summary, the questions which are applicable have all been completed in our submissions. Ones that are not relevant have been skipped (As advised in their instruction notes).

Hope the above make sense
