1.1 This Variation Agreement is supplemental to the Original Agreement. Except as expressly varied by this Variation Agreement, the Original Agreement shall remain in full force and effect. Terms defined in the Original Agreement shall have the same meaning in this Variation Agreement, unless otherwise provided by this Variation Agreement.
