- Regulated facility type: The application is to add a new Installation activity, Section 5.4 A(1) (b) (i) Recovery or a mix of recovery and disposal of non-hazardous waste with a capacity exceeding 75 tonnes per day (or

100 tonnes per day if the only waste treatment activity is anaerobic digestion) involving biological treatment.

• Regulated facility location: Canterbury WTW and STC, Sturry Road, Canterbury, CT2 0AA
