## Schedule

*As discussed on the telephone, the Habitats Regulation Assessment (HRA) appropriate assessment carried out by the Environment Agency concluded that;*

*“The permission, plan or project (PPP) cannot be ascertained to have no adverse effect on the integrity of the following site(s), either alone or in combination with other plans and projects...”:*

*West Midlands Mosses SAC (UK0013595)^*

*Midland Meres and Mosses Phase 2 Ramsar (UK11080)^”*

*The HRA confirmed that process contributions were over the screening thresholds for acid deposition at the protected sites.*

### **1. Provide a proposal to reduce acid deposition resulting from activities at the installation.**

*Submit a proposal to reduce the levels of acid deposition at ecological sites, including but not limited to, Special Areas of Conservation (SAC) sites, Ramsar Sites and Sites of Special Scientific Interest (SSSI). The proposal should be validated by modelling, reports, and updated documents if the new proposal necessitates previously submitted documents to be re-written.*

### **2. Pay £1,930 for re-consultation.**

*If point 1 of the Schedule 5 notice requires the submission of new documents, revised documents and (or) re-modelling, a fee of £1,930 will be payable for amendments to your application. Please note, if any changes to this permit variation application are deemed significant, they may attract additional fees.*
