CW9 7NU, Lostock Sustainable Energy Plant Ltd: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Lostock Sustainable Energy Plant Ltd. Please use the reference number below when making comments on this application.

- Permit Number: EPR/WP3934AK/V004
- Regulated facility type: The facility is an installation permitted under Section 5.1 A(1)(b) activity 'the Incineration of non-hazardous waste in a waste incineration plant with a capacity exceeding 3 tonnes per hour' under the Environmental Permitting Regulations. This application is to vary the permit as follows:
- Increase the annual capacity of the installation from 600,000 tonnes per annum to 728,000 tonnes per annum
- Amend the Site Layout/Installation Boundary/Operating Techniques to align with the design of the Facility allowing for its design evolution since the environmental permit was originally granted
- Add two non-hazardous waste types to the permitted waste types
- Introduce an additional emission point to allow the discharge of excess process effluents to sewer.
- Regulated facility location: Lostock Sustainable Energy Plant, Lostock Gralam, Northwich, Cheshire, CW9 7NU
