Environmental setting including: <ul style="list-style-type: none"><li>• geology</li><li>• hydrogeology</li><li>• surface waters</li></ul>	Site is located on the floor of an old shallow quarry in the Seaford Chalk, just north of the A226. There is minimal made ground between the floor of the site and the top of the quarried material, although some local filling has occurred. No surface waters are present within the site or its immediate locality. Hydrogeological flow is northwards, towards the Thames estuary.
Pollution history including: <ul style="list-style-type: none"><li>• pollution incidents that may have affected land</li></ul>	No pollution incidents have been discovered recorded on site. The site was originally a shallow chalk quarry and is recorded as a paper works from c.1890 onwards.



<ul style="list-style-type: none"> <li>historical land-uses and associated contaminants</li> <li>any visual/olfactory evidence of existing contamination</li> <li>evidence of damage to pollution prevention measures</li> </ul>	<p>The site was still shown as a paper mill on the 1970's OS maps. Since the mill closed, the area has been used for a number of factory/manufacturing/storage uses. Minimal evidence of these uses remain on the site itself, though railway lines set in concrete are visible around the local area and large parts of the area (site included) are concrete surfaced. The current buildings used by the site were built c.1995. No visual or olfactory evidence of contamination is present on site. There is no evidence of damage to pollution prevention measures on site.</p>
Evidence of historic contamination, for example, historical site investigation, assessment, remediation and verification reports (where available)	No evidence of historical contamination is available for the site.
Baseline soil and groundwater reference data	Baseline geological data from BGS. As the site is a recycling facility completely surfaced with concrete, there is no interaction with subsurface soil or groundwater.
