### DA11 9AD, Green Hydrogen 3 Limited: environmental permit consultation

#### The aim of this consultation is to ask whether you have any comments relevant to the permit application

We are seeking comments on the application for Green Hydrogen 3 Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/MP3624S/A001
- Regulated facility type: This application is for a hydrogen production facility that will form part of a multi operator installation with the existing Northfleet Paper Mill and will produce hydrogen by electrolysis for use in the paper mill's boilers. The application is therefore to carry out the scheduled activity of producing inorganic chemicals such as hydrogen, which is a Section 4.2 Part A(1) (a) (i) activity.
- Regulated facility location: Northfleet Hydrogen Production Facility, Northfleet Mill, Crete Hall Road, Gravesend, DA11 9AD
