As per email chain below, Southern Water are happy with the proposed limit on operation of the boilers. In summary this will be that they will be able to run on biogas, but not in conjunction with the CHP, and that they will permitted to run for less than 500hrs on gas oil.

Document 'Application Variation - V002 -790101_CombustionPlant_Gravesend ' advises that boiler 2 operates on natural gas and light oil and not biogas. Hi Sarah

I have a quick clarification on point 2 of the below. I have been speaking with our AQ team who are querying why the boilers would need to be modelled when the site has been modelled, at a worst case, with the CHP running at 100%. If the CHP doesn't operate only then do the boilers kick in. The ELVs for the CHP are higher than the boilers therefore, providing a conservative output

If you require us to model the boilers, we would have to redo the whole of the modelling as the previous models/report where done by Ricardo. We cannot amend thirdparty models. This would not be available until 24th January as time would be needed to set up and run the models and update the report.

Please can you confirm that the modelling is definitely required to be updated and you are happy to extend the deadline for this to 24th Jan?
