DA8 1AX, MUZTRANS LTD: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for **MUZTRANS LTD**. Please use the reference number below when making comments on this application.

- Permit Number: **EPR/DP3126LF/A001**
- Regulated facility type: The proposal is to Collect full mixed COSHH bins from sites (1000Ltr/600ltr) and return to depot once full. Once back at depot wastes will be separated by Hazard and same items put in UN rated Drums that have sealed lids, in separate bays in warehouse on fully impermeable and sealed drainage. The total COSHH Haz storing at any one time is 3.5t, and Non Haz 0.5t, for a maximum term of 2 weeks.
- Regulated facility location: **Muztrans Ltd, Bronze Age Way, Erith, DA8 1AX**
