The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for City Batteries Ltd. Please use the reference number below when making comments on this application.

- Regulated facility type: The conversion of a Waste Management Licence to a multi-regime permit (installation and waste operation) including scheduled activities, due to an application for an increase in hazardous waste storage and the implementation of the Industrial Emissions Directive.
 - 5.3A(1)(a)(ii) – Hazardous waste treatment – dismantling of lead-acid batteries for recovery
 - 5.3 A(1)(a)(iv) – Hazardous waste treatment – bulking of hazardous waste for transfer
 - 5.6 – Hazardous waste storage
 - Waste Operation – bulking of non-hazardous waste for transfer
- Regulated facility location: Albion Yard, Manor Road, Erith, Bexley, DA8 2AD
