The surrounding land is predominantly used for arable farming and some residential properties nearby.</u></p> <p><u>The site is relatively flat with some of the surrounding areas slightly undulating. There is a small, wooded area consisting of mostly deciduous trees next to the site to the west. There are no SAC, SPA or Ramsars within 5km of the installation. There is one SSSI within 5km and one other nature conservation site within 2km which is a local wildlife site (LWS).</u></p> <p><u>Topsoil over the entire site is of stagnosol type.</u></p>

Permitted activities	<p><u>Poultry Farm (Broilers)</u></p> <p><u>Application is made to increase from current capacity of 240k birds in 5 houses to 360k birds across 8 houses.</u></p> <p><u>The operational areas around the sites are laid with concrete.</u></p> <p><u>All feed deliveries are received in covered lorries and stored on-site in galvanised steel silos. Once the houses are depopulated, litter is removed and placed in covered vehicles and sent to power station or to third parties for land spread. The houses are then washed, cleaned and disinfected ready for the next crop of birds. An underground tank is in place to hold wash water and effluent during this process for removal by approved wastewater contractors who hold waste carrier permits, all information is documented on waste transfer notes on site.</u></p> <p><u>Diesel is stored on site in a bunded tank beneath the generator. Small quantities of disinfectant are held on site for ongoing biosecurity management, these are kept in the sites dedicated chemical store on bunded containers.</u></p>
