# DN15 0DB, Egdon Resources UK Limited: environmental permit consultation

#### The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Egdon Resources UK Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/AB3609XX/V007
- Regulated facility type: Wressle 1 site is an onshore oil and gas operation. The application seeks to add a new installation activity for the refining of natural gas in excess of 1,000 tonnes per year. The application also seeks to vary the current mining waste operation, water discharge activity and groundwater activity. Wressle wellsite will be extended from the southern boundary and two new wells will be drilled.
- Regulated facility location: Wressle 1, Clapp Gate, Scunthorpe, North Lincolnshire, DN15 0DB
