I need to ask you for some missing information before I can do any more work on your application. Please provide us with more information to the following questions:

- Part B3, Table 1a please split the annual throughput total of 200,000 tonnes per year into hazardous waste and non-hazardous waste. – Annual Waste Inputs updated to 200,000tpa Hazardous Waste and 200,000tpa Non-Hazardous Waste. Form Part B3, Table 1, Management Plan Document and Appendix 3 – Waste Schedule all updated and attached accordingly.
- 2. Part B3, Table 3a You need to demonstrate compliance with the Waste Treatment Best Available Technique (BAT) reference document (BREF) (published August 2018) or demonstrate why this is not applicable to this installation. Please see previous response on this matter sent on 14/02/19.
- 3. Part B3, Table 3c You have indicated that Pulverized Fuel Ash (PFA) is a raw material to be used as a product additive. Please amend your management plan to include the use of PFA in the treatment process. Management Plan updated at Section 2.5 'Raw Materials' to include further information on the use of PFA in the treatment process.
- 4. Part B3, Section 1 We consider PFA to be a waste type (European Waste Catalogue code 10 01 wastes from power stations and other combustion plants). Please amend your management plan and list of wastes to include PFA as an accepted waste type or provide justification for excluding this from your list of wastes. The receipt of PFA for use in the treatment process is done so as a product not a waste. The material is received from suppliers in accordance with a WRAP Quality Protocol Document to an established specification. The Quality Protocol (QP) sets out end of waste criteria for the production and use of PFA arising from combustion activities. If these criteria are met, the resulting outputs will be regarding as having been fully recovered and to have ceased to be a waste. It is fully understood that where producers, processors and users do not comply with the measures set out within the QP (they are not obliged to), the material will normally be considered to be a waste and waste management controls will apply to its use.

5. Site plan – You state in section 2.3.4 of your management plan that 'clean planings' will be stored in a separate, clearly identified location away from the tar bound planing stockpiles. Please amend your site plan to show these separate areas. – Please see attached updated drawings as requested.
