DN31 2TT, RAPID COLLECTIONS LIMITED: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for RAPID COLLECTIONS LIMITED. Please use the reference number below when making comments on this application.

- Permit Number: EPR/WE0503AB/V004
- Regulated facility type: Substantial variation of an existing waste facility which operated under a SR2022 No.4, to a bespoke HCI Transfer with Physical Treatment. Treatment will continue to consist of physical/mechanical treatment and separation via the shredder and trommel and crushing and screening of hardcore, soils and aggregates.

The facility will retain annual tonnage at 75,000 tonnes. (Storage 15,000).

Proposed change to allow external storage and treatment of wastes.

No new treatment activities proposed.

Current EWC codes will be retained except the inclusion of two new EWC codes 19 12 12 – treated waste from MRF recycling facilities and 19 12 12 – Incinerator bottom ash. No Asbestos or other Hazardous wastes will be accepted.

- Regulated facility location: Moody Lane Materials Recycling Facility, Energy Park Way, Healing, DN31 2TT
