### DN40 3DZ, VPI Immingham B Limited: environmental permit consultation

#### The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for VPI Immingham B Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/NP3005PR/A001
- Regulated facility type: VPI Immingham OCGT Power Station will consist of one Open Cycle Gas Turbine (OCGT) approximately 767 Megawatts thermal (MWth) in size operating under Section 1.1 Part A(1)(a) of the Environmental Permitting Regulations (EPR) for the burning of fuel in an appliance with a rated thermal input of 50 or more MW.

The main equipment making up the OCGT includes a gas turbine, electrical generator, main transformer, closed loop fin-fan cooling system and water supply. The OCGT will be fitted with dry low NO<sub>x</sub> (oxides of nitrogen) burner technology.

- Regulated facility location: VPI Immingham OCGT Power Station, Land to the north of the, VPI Immingham HP power station, South Killingholme, Immingham, DN40 3DZ
