What happens next?

Allocation

Your application has been added to our work queue to be allocated to a Permitting Officer to be checked. A Permitting Officer will contact you as soon as they pick up your application.

The application fee of £9,527.00 for the substantial variation (in line with Section 1.17.9 of the EA Charging Scheme) and review of an emissions management plan was made on 08/07/2022 by the operator via BACS payment. The payment details and reference number are included in Application Form Part F1 (Remittance Number: PSCAPPSKEL0722).

Pre-Application advice was sought for this application whereby the Waste Recovery Plan was not accepted as the EA were "Not yet satisfied to agree recovery". This was principally due to there being no planning consent in place at the time. However, there is now a planning consent in place for the site and minor revisions have been made to the scheme of restoration; principally to increase flood attenuation capacity.

I trust the application documents provide adequate information to support the determination of this EPVA.
