
Hi Steve,

I have taken over the permit review for this site as Maria has now left the Agency. I've been finishing the draft variation notice ahead of sending it to you for operator review and just wanted to let you know that the following waste codes are no longer included as standard for composting permits. Maria may have confirmed this with you already but I have removed them from the permit. I don't think this should be an issue as none of them are the waste stream you stated is treated at site anyway.

<mark>03 03 07</mark>	mechanically separated rejects from pulping of waste paper and cardboard
<mark>03 03 08</mark>	wastes from sorting of paper and cardboard destined for recycling
<mark>17 02 01</mark>	wood
<mark>19 12 07</mark>	wood other than that mentioned in 19 12 06
<mark>20 01 38</mark>	wood other than that mentioned in 20 01 37

I do need an alternative site plan providing please as the one submitted as part of the review does not include location features such as road names etc. and the boundary isn't very clear. The below plan was taken from the variation in 2009. I was going to use this plan but it isn't legible in the format it's been saved in and the

road name would be too small to read once included in the variation notice. If you could provide a similar plan with a clear site boundary but also including a location feature, such as the main road names by **30<sup>th</sup> March 2022**, that would be great. As soon as I have this I can get the notice sent for operator review.
