

## About this consultation

### DT2 8WG, Nuclear Restoration Services Limited: environmental permit consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Nuclear Restoration Services Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/CP3329LD/A001
- Regulated facility type: The regulated facility will enable the partial infilling of below ground voids at the Steam Generating Heavy Water Reactor and Dragon Reactor at the Winfrith Site. Infilling works will be undertaken as a recovery activity, with site derived construction and demolition materials, which are classified as non-radiological and non-hazardous waste. A separate permit variation application is being made to cover use of waste on-site for infilling, which are subject to a radioactive substances regulations permit. The wider regulated facility will support decommissioning at the Winfrith Site and align with the agreed end state design for the facility.
- Regulated facility location: Winfrith Site, Gatemoor Road, Newburgh, Dorset, DT2 8WG

Providing a business can prove that the proposed activities meets all the legal requirements, including environmental, technological and health requirements, then we are legally obliged to issue a permit, even if some people do not approve of the decision.
