Relevant Offences

The Environment Agency issued the attached list during a recent application for a new Environmental Permit for Recycled Material Supplies Limited (RMS).

This document provides a Post Conviction Plan to demonstrate how RMS has evolved since this time into a significant waste management company serving London.

Three relevant convictions resulted in fines. However, these all refer to incidents that occurred in 2010 and 2011.

The other convictions appear to relate to offences that occurred in 2012 and 2013, all resulted in a conditional discharge of 2 years, which are typically imposed for less serious offences.

Post Conviction Plan

The time lapse since these convictions is testimony to the changes in RMS in becoming a highly reputable waste management company.
