G33 5BH, Construction & Environmental Services Limited: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Construction & Environmental Services Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/KP3523LD/A001
- Regulated facility type: The proposed inert waste landfill is part of a plan to restore Colsterworth Triangle Quarry to agricultural land, in line with the approved restoration plan for the nearby Colsterworth Landfill Site. This plan was granted planning permission on 8th June 2006 (S22/0289/05). To achieve this, it's estimated that between 850,000 and 900,000 tonnes of inert waste will need to be brought in to make the land suitable for farming, following the conditions of the existing planning permission. The process of restoring the quarry using this waste is expected to take about 6 years, with around 150,000 tonnes of waste being brought in each year.

To help with the final restoration, subsoil and topsoil that was removed earlier and stored in bunds around the site will be used. Additionally, monitoring will be carried out for groundwater and landfill gas, with boreholes placed around the edge of the landfill area, including two points inside the waste to track landfill gas.
- Regulated facility location: Colsterworth Triangle Quarry (Stainby), Crabtree Road, Grantham, Lincolnshire, G33 5BH
