GL1 3QD, Allstone Sands Gravels Aggregates Trading Co. Ltd: environmental permit consultation

The aim of this consultation is to ask whether you have any comments relevant to the permit application

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Allstone Sands Gravels Aggregates Trading Co. Ltd. Please use the reference number below when making comments on this application.

- Permit Number: EPR/AB3709HV/V002
- Regulated facility type: The site is currently operating under the standard rules permit SR2010 No.12.
Operations include crushing, washing and screening of inert and non-hazardous waste to produce recycled aggregates. The Operator has applied to vary their standard rules permit to a bespoke permit in order to maintain soil washing as an activity. The operator also wishes to add an additional waste code to the permit (17 09 04) and to increase the size of their permitted area.
- Regulated facility location: Allstone Aggregate Recycling Facility, Myers Road, Gloucester, GL1 3QD.
