### GL2 5HY, Avon Specialty Metals Limited: environmental permit consultation

**The aim of this consultation is to ask whether you have any comments relevant to the permit application**

We want to make the best decision when permitting. Listening to the views of others helps us to take account of concerns, or local environmental factors, that we may not be otherwise aware of.

We are seeking comments on the application for Avon Specialty Metals Limited. Please use the reference number below when making comments on this application.

- Permit Number: EPR/JB3601UD/A001
- Regulated facility type: 1.16.16 Metal recycling site - mixed metals.

The proposed activity accepts waste and virgin metals in shipping containers, vans or heavy good vehicles.

The metals are stored in drums, bags, strapped to pallets, in metal cages or boxes, these are covered at all times.

The treatment taking place includes; cleaning of metals, cutting and grinding using cutters and grinders, shot blasting and pickling to remove coating.

The activity will not store no more 500 tonnes and the annual throughput is 1,200 tpa
